## Good Egg Stock Dog Benefit Trial

The Antelope Valley Stockdog Club will be holding a benefit stockdog trial on Saturday April 3, 2010 at TASK Farms in Leona Valley, CA .

The trial is being held for the benefit of Mike Burks' dog Sport. As some of you may know Sport recently underwent emergency surgery for a life threatening condition. While he pulled through the surgery Sport is not completely out of the woods yet and the vet bills are extensive. The benefit is to help Mike cover some of the vet bills.

There will be three trials held that day (1) an AHBA Ranch Course (HRD) and Tests on Sheep (sanctioning pending); (2) a USBCHA style Novice, Pro-Novice and Ranch (open to Open Handlers and anyone wanting to try a slightly more difficult challenge); and (3) a "Virtual Trial" for anyone who cannot make the trial but would like to help support the benefit through a donation.

The USBCHA style trial will not be sanctioned. The Novice trial will be Outrun, Lift, Fetch, Wear/Drive through one or two panels, and pen. The Pro-Novice Course will be a shortened open course with no shed. The Ranch Course – open to all dogs wishing to compete including dogs that have already run Open class will be a shortened Open Class course including a shed.

We are also planning some fun "day of" events possibly including a team brace competition and other fun things we might think up.

**Cost:** \$25 per run – any trial or class.
